OPTION 2

FREQUENTLY ASKED QUESTIONS:

Can any company or organization sign up for the Corporate Membership Program?

Absolutely! Big or small, any organization can sign up for a Corporate Membership with Bike Share Toronto. Enrollment in the Corporate Membership program requires a minimum of 10 employees.

What kind of membership can I get under the Corporate Membership Program?

When you sign up, you can choose to either get a discounted Annual 30 or Annual 45 Membership. The Annual 30 membership gives riders unlimited 30-minute rides, while the Annual 45 gives unlimited 45-minute rides. Overage fees apply on trips that exceed either 30 or 45 minutes, respectively and are billed to the individual member's credit card on file (required upon sign up). Can I use additional discounts with the Corporate Membership?

Additional discounts cannot be applied with the Corporate Membership.

Is there a minimum/maximum number of employees required to sign up?

Bike Share Toronto welcomes all types of organizations to apply for our Corporate Membership Program, with a minimum of 10 employees.

How long does the Corporate Membership last?

Your Corporate Membership is an Annual membership and is valid for 1 year from the date of purchase. It will not auto-renew. To renew your Annual Membership under the Corporate Membership Program, all members must revalidate their employment with the participating organization through a 2-step email validation process.

Can my family and friends sign up for a Corporate Membership Program?

The Corporate Membership is non-transferable and valid only for employees of registered organizations.

Is there any financial obligation from my company to sign-up?

There is no financial obligation from the company if you go with Option 1 of the Corporate Membership Program. Financial obligations to the company only occur if proceeding with Option 2.

What if I'm already a Bike Share Toronto member? Can I still join the Corporate Membership Program?

If you have purchased a regular annual membership within the last 30 days, you can call Customer Service to request a refund and re-purchase a discounted corporate membership through the portal. If you are within your last 30 days of a current annual membership, you are able to purchase the discounted corporate membership and it will be added to your account and automatically begin when your current subscription ends.
